

Colonial Park is located in the Lower Rouge River in the [City of Inkster - City Hall](#). Existing wetland areas were expanded in an effort to better manage stormwater and improve habitat for wildlife.

9/8/22 - Under an [U.S. EPA Region 5 \(Great Lakes Region\)](#), Great Lakes Restoration Initiative (GLRI) Grant (Grant GL-00E02700) the Alliance of Rouge Communities will soon solicit construction bids for the habitat improvements at Seeley Creek in [City of Farmington Hills, Michigan - Municipal Government](#). This habitat project will enhance 5 acres of riparian wetland and 1,600 feet of Seeley Creek between 12 and 13 Mile Roads, upstream of the Rouge River. The project will improve the riparian vegetation buffer adjacent to the creek, stabilize several erosive gullies that flow into the creek, and create several fish and wildlife habitat structures within the creek.
