# 4. Summary of November 9, 2021 Executive Committee Meeting

The motion was made by Jacy Garrison, Oakland County to accept the November 9, 2021 meeting summary. The motion was seconded by Rebecca Runkel, Novi, and passed unanimously.

# 5. Executive Director Report (ARC Staff)

#### a. 2021 Executive Director's Annual Report

Annette DeMaria reported the annual report is available on the ARC's website and a hyperlink is provided in the agenda. There will be a brief presentation at the Full ARC meeting on Thursday, March 24 that will highlight services provided in 2021.

# b. MS4 2020-2021 Progress Reports

Annette DeMaria reported that the 2020-2021 progress reports are due to the state for most members. Annette stated the reporting period is for January 1, 2020 through December 2021. Annette mentioned there are two reports due: one for the two year progress report and the second year is for alternative compliance on the post construction standards which covers 2021. Annette stated ECT provided guidance for how to respond on the reports. Annette asked if there were any questions, there were none.

### c. ARC Collaborative PPP, PEP and IDEP Progress Reports

Annette DeMaria reminded members that the ARC does the reporting on the collaborative plans. The report links to the PEP and PPP progress reports have been provided previously. The IDEP progress report link will be provided later today or tomorrow. Chris O'Meara will send out the links to the members when available.

### d. Rouge Rescue Feedback

Annette DeMaria reported at the last full ARC meeting she was asked to look into the Rouge Rescue. Annette stated she had a meeting with Friends of the Rouge. After the meeting in January, Annette sent an email to the group that outlined the options for Rouge Rescue. Friends of the Rouge (FOTR) is rehabilitating Rouge Rescue to be different than previous years. FOTR is focusing Rouge Rescue more to events they are leading versus supporting community led events. FOTR is still willing to advertise community events to the members at no charge but if the ARC wanted to continue Rouge Rescue with support to communities the cost would be \$15,000 watershed wide or an individual cost of \$500 per community. There were a couple of communities who do not need FOTR support. Annette stated based on feedback received, no action has been taken.

Karen Mondora asked if there is any requirements for communities to participate in Rouge Rescue. Chris O'Meara stated the ARC is only responsible for <u>promoting</u> volunteer and monitoring FOTR events.

Annette mentioned the ARC should reexamine the 5 year plan and update them and then establish a new 5 year budget to support the plans. Annette stated it will more than likely be up to the PIE Committee.

Noel Mullet stated if the re-application is in April 2023 then EGLE would issue the new permit in October 2023 which would mean alternative plans would be needed by April 1. Annette stated she will confirm the dates. Annette mentioned to FOTR that the ARC would most likely not support the \$15,000.

# Henry Ford Estate Dam Fish Passage

- Contractor is conducting vegetation maintenance. Lowering of the water control will take place over the next two summers. With partial opening this July.

To facilitate the successful completion of this natural area restoration, the footpaths within the adjacent woods will be closed during this establishment phase.

#### **GRANTS AWARDED**

John O'Meara stated the Wilcox/Phoenix/Inkster grant have now be moved to ongoing above and reported that on the following:

#### Rouge River AOC Habitat Restoration - Wilcox/ Phoenix/ Inkster Habitat Design (\$785,100)

EPA has awarded a GLRI grant to the ARC to provide restoration designs for habitat at Wilcox Lake, Phoenix Lake and Inkster Park. These activities when implemented will result in restoration/enhancements to 16.5 acres of habitat, which includes lake, wetland/wet meadow, and riparian areas.

- Field work has begun
- Design is underway

Annette DeMaria stated that the grant below and can be moved up to ongoing grants above. Annette reported that on the following:

**Regional Investigational Monitoring Work Plan for Southeast Michigan (\$40,000)** - The GLWA was awarded funding in Summer 2021 and GLWA has asked ARC to complete the development of a work plan framework to conduct investigational monitoring in the GLWA wastewater service area to identify stream segments that are being impacted by sewage sources. This includes Macomb, Oakland and Wayne Counties. The ARC developed a work plan and budget which his approximately \$2M across the region over 5 years. Annette indicated that the ARC has started to attend meetings that are held with County officials and sanitary sewer drainage districts in local municipalities to discuss their interest in pursuing the program and figure out where the funding comes from. The ARC has met with Oakland County's Public Works Commissioner, Candace Miller and they will pursue whether there is a regional program or not. There is also support from Oakland County WRC. Over the next month, the ARC plans on meeting with three sewer districts (GWK, Evergreen Farmington and Clinton Oakland).
