3. Approval of December 13, 2006 Meeting Minutes.

A motion was made to accept the minutes, it was supported, there was no discussion, and it passed unanimously.

4. Additions or changes to the Draft Meeting Agenda. Phil Sanzica requested a discussion of the 319 grant and USGS gages in Oakland County be added to the Agenda.

5. Chair's Report

- a. Presentation by SEMCOG (Chuck Hersey) on approaches to the Bolt Decision. Mr. Hersey distributed and discussed the following three documents:

- **6.** Treasurer's/Finance Committee Report.
 - a. Mr. Faas reported the agreement with Wayne County has been executed for fiduciary services in 2007.
- 7. Executive Director Services Committee Report.

Mr. Swallow reported that Ms. Cave has withdrawn her application for the ARC Executive Director position. On Monday January 22, 2007 the Executive Director Services Committee met and unanimously decided to recommend ECT for the position, with Mr. Jim Ridgway as the Executive Director. After Ms Cave, ECT received the next highest score during the evaluation process. There was a brief discussion of the proposal submitted by ECT. There was concern expressed by several members over the Ann Arbor location of the office that ECT has proposed since it is not located in the Rouge River watershed. The Ann Arbor location is where the ECT staff is located that are named in the ECT proposal. It was also mentioned that if Mr. Ridgway should leave ECT the contract should cease. Since Mr. Ridgway is very involved in Oakland County there was concern over a conflict of interest in grant competition between Oakland County and the Rouge communities. It is expected that ECT will develop a scope of services and assume the Executive Director position by March 1, 2007.

A motion was made to offer ECT the Executive Director position provided that they revise their ARC office location to their Detroit address. The motion was seconded, there was no further discussion, and the motion passed unanimously. Mr. Giberson thanked everyone for all of their work.

 - i. Progress Report. The ARC Bacterial Source Tracking report was submitted to the MDEQ and we are awaiting comments. A subcommittee of the Technical Committee met to discuss the IDEP Comparison report. Suggestions were made for revisions to the report, and the report was revised. The MDEQ notified the ARC that they are interested in the results.

d. Oakland County.

Mr. Sanzica distributed three handouts (Attachments "D", "E", and "F")

Attachment "D" – requests permission of ARC to apply for grant to update the plan to 319 standards and asks for letter of support from ARC.

A discussion of updating the subwatershed management plans followed. The City of Southfield will draft a letter to the ARC for grant support that includes the development of a watershed management plan template for the rest of the watershed that meets 319 standards. Jack Bails will draft a letter in the interest of having an ARC member appointed to the Environmental Action Committee.
